**California Peacekeepers Mounted Shooting Association  
Waiver, Release and Indemnity Agreement**

**The undersigned understands and acknowledges the following:**

(1) That the California Peacekeepers Mounted Shooting Association is a California nonprofit association affiliated with the Cowboy Mounted Shooting Association, a national organization. Members of the California Peacekeepers Mounted Shooting have joined together to promote their mutual interest in the sport of mounted shooting. Club members, officers and directors donate their time and property to the association without compensation. (2) That mounted shooting, and the handling of loaded firearms and horses, or the observation of the same, is a dangerous activity, and that participation in mounted shooting as a rider, bystander, participant, contractor or volunteer exposes me to a substantial and serious risk of property damage, personal injury or death to myself and my horse. (3) That as a rider, I consider myself experienced enough to safely participate in mounted shooting, and (4) That I have read and voluntarily signed this Release, Waiver of Liability and Indemnity Agreement, or if a minor, a responsible parent has signed on my behalf.

**The undersigned agrees as follows:**

(1) To assume all the risks of mounted shooting. (2) To waive, release and hold harmless the California Peacekeepers, and its officers, directors, members, agents, assigns, insurance companies, arena owners or contractors, and their heirs ("Released Parties") from liability for any and all claims for loss and/or damages for death, personal injury or property damage, including attorney fees ("Claims") which I may have, or which may accrue to me or my heirs as a result of my participation in mounted shooting, including any claims that are known and unknown, foreseen and unforeseen, future or contingent. (3) To not now, or at any time in the future, directly or indirectly commence or prosecute any action, suit or other proceeding against the Released Parties or any of them, arising out of or related to mounted shooting, and if such action is undertaken despite this waiver and release, to indemnify and hold harmless the Released Parties from all cost or liability which may ensue. (4) This Release, Waiver and Indemnity Agreement is binding upon me, my spouse, legal representatives, heirs, successors and assigns.

**ADDITIONAL CMSA RELEASE**

I understand that I am participating in a sport, which contains dangers, and risks may arise, including, but not limited to, accidental injury, the forces of nature and illness. In consideration of the right to participate in these events and the services provided for me by the Cowboy Mounted Shooting Association and its agents, I have and do hereby assume the risks associated with such events. The contestant shall at his own expense, defend management and/or all sponsors, their cardholders, or employees from any and all such claims and indemnify, from any and all liability, damage and costs arising from injuries to person or property occasioned by any act or omission of the contestant. Membership in the CMSA is a privilege and requires that those who compete in events meet all local, state and federal requirements to legally possess firearms for the purpose of such competition. Therefore it is the responsibility of all members to insure that they are legally able within the state or country that they are competing in to own and/or possess firearms. If the CMSA is notified by proper authorities of a member's inability to legally possess the firearms required to compete in CMSA sanctioned events that membership will immediately be suspended. By joining CMSA, I am agreeing that images of my horse, equipment and myself may be photographed, videoed or recorded in any way and re-used without my permission and without compensation. I further agree to support and enforce CMSA Rules as stated in the CMSA Rule Book. This Solidarity Agreement binds all CMSA Members to enforce CMSA Rules and assure our competition cardholders they will play the same game worldwide when they travel for CMSA competitions. All of these provisions also apply to California Peacekeepers Mounted Shooting Association.
